April 21, 2021 - Public Meeting: TMWA Board of Directors Meeting - Staff provided an informational report to the Board describing a proposed feasibility study that will examine the potential benefits of bringing recycled water for irrigation use in Warm Springs Valley. The Study would also evaluate the aquifer as a site for groundwater banking—i.e. injecting treated water into the aquifer during winter months for later use during the summer, peak-use period.

March 31, 2021 – “Award for Excellence” from WaterReuse Association: the WaterReuse Association recognized the OneWater Nevada initiative and Truckee Meadows Water Authority’s (TMWA) Lydia Peri, among the recipients of its Awards for Excellence. OneWater Nevada was named in the “Community Water Champion” category. This award recognizes the accomplishments of utilities and local government entities that ensure a safe, reliable, locally-

controlled water supply. This recognition was featured on TMWA’s website and social media channels.

August 6, 2020 – Meeting With NDEP: The Nevada Department of Environmental Protection (NDEP) conducted an online workshop with over 50 participants attending. Representatives from OneWater Nevada presented in-depth information about their evaluations to date, water quality results, and shared where Advanced Purified Water is in use in other parts of the country. They described treatment technologies and long-term program objectives.

March 2019 – TMWA Employee Education Sessions: These sessions were held to both educate staff and prepare them to be better able to navigate conversations they may have with friends and family members regarding Advanced Purified Water project work.
